Justification for use of Sobo Gold

Sobo Gold is an excellent cleaner, degreaser for deck, bulkhead, drill-floor and equipment. Sobo Gold combines exemplary performance (far outstripping many competitive products) with a Gold classification under the Offshore Chemicals Notification Scheme with a substitution warning under UK National Plan 3.

Compared to similar products on the market, Sobo Gold is only used at 2% which minimises the amount of discharged chemical products into the ocean.

The material that carries the substitution warning in Sobo Gold is an alcohol ethoxylate surfactant. This material comprises less than 5% of the total product formulation and thus only < 0.1% of active surfactant is released at any time of this products use and discharge.

The biodegradability of this material is >65% in 28 days. Furthermore it is not expected to bioaccumulate. This surfactant has an average molecular mass of 422g/mol and is relatively biodegradable.

This template will expire in 13/11/2027. We are unsure if we will renew the product registration after this time as there is a similar gold banded product with no substitution warning is available from our product portfolio called Sobo S Gold 08.
